Mayor Davis reported we will do legal research on down time for businesses with storm damage and look into extending the time on tax exemption upon completion and reconstruction of their new buildings.

PLANNING

Whitney Choat, City Planner presented the Planning Agenda to the Mayor and Board of Aldermen.

Item #1 Application by Butler Properties for subdivision approval for 7.63 acres of property on the south side of Stateline Road, west of Swinnea Road. Ms. Choat reported they have been requested to have an ingress/egress on the Swinnea Road side to eliminate the need for another curb cut on Stateline Road. It was unanimously approved by the Planning Commission. A motion was made by Alderman Jobes to approve item #1 as recommended by the Planning Commission. Motion seconded by Alderman Guy. Following discussion motion passed unanimously with Alderman Huling being absent.

MAYOR'S REPORT

Mayor Davis reported he declared a State of Emergency at 5:45 p.m. on February 5, 2008. A motion was made by Alderman Cady to accept the Declaration of Emergency and to make it part of these minutes. Motion seconded by Alderman Guy. Motion passed unanimously with Alderman Huling being absent.

Mayor Davis reported there is some damage to roofs and windows basically in Carriage Hills South and the Alleghany Cove area. The debris had been removed from the trees. Tarps were put on roofs last night where there was exposed wood. One house had a tree to go through. That house was secured last night. The City helped get the tree out of the way. That area should be cleaned up totally by tomorrow. Stateline to Airways should be opened by tomorrow and people will be able to get back in to some of their businesses. There are some people who could not get in at all today, because our Police have had that area secured to keep out looters, etc. There is also danger with live wires and lines being down. Power is being restored in phases in the Airways Industrial Park. The traffic lights at Northwest and Stateline, and at the interstate are being operated by generator. Mayor Davis reported that we are thankful as a City that no one was injured

during this storm and we want to make sure no one is injured after the storm with leaning concrete walls, steel beams, and things of that nature. He reported that the projection is that by tomorrow each indivisual business should be able to come in with their crews. He reported that this storm was different than the last straight wind storm that came in and caused massive cleanup for a week. Most of this damage has been contained to private property, therefore the City can not go onto that private property unless there is a life threating issue at hand or a traffic issue. State Farm is setting up a mobile claim center at the Arena for anyone who has State Farm Insurance on their residency.

Mayor Davis thanked every public safety agency in DeSoto County including every City, The Sheriff's Department, the Emergency Disaster Group. He reported we had immediate response. He reported that within minutes those damaged area were tightly secured with Fire and Police personnel. He reported that he appreciates that in time of need all of the Cities and the County came together to help.
