Mayor Davis called the meeting to order. Alderman Jim Loftis opened the meeting with prayer. Following the Pledge of Allegiance led by Alderman Guy, a motion was made by Alderman Guy to approve the minutes of the meeting of March 4, 2008 with any corrections, deletions, or additions necessary. Item #1-Conditional Use Permit Application for a Reader Board at the new Royal Gallery Furniture Store on Airways Blvd. Ms Choat reported they are in compliance. She reported their response was that the windows are double pane glass and the glass would have to be replaced. She reported they reached an agreement for two panes per month to be replaced. That was in July of 2007. Ms Choat reported that as of today there has been four replaced. She reported the conditional use time will be up in a couple of months therefore she is asking for a revocation and have them possibly come back after they have replaced the windows and after the landscaping is in compliance and have them renew a conditional use permit and go through the application process again. A motion was made by Alderman Huling to accept Item #2 as presented. Motion seconded by Alderman Loftis. Motion was put to a vote and passed unanimously.
