CITIZEN'S AGENDA

Chief of Police, Tom Long, came before this Board to give presentation awards to some Officers. Chief Long awarded Sergeant Steve Howell, Former Sergeant of Dispatch, Chris Shelton and Lieutenant Mark Little (who was absent) for the implementatation of the 2004 Southaven Police Department Grant received to allow information sharing between all DeSoto County law enforcement agencies. Thanks to these men, this is now a realization. They did an exceptional job on this project as well as their day to day duties. They were given a Certificate of Appreciation.

Next, Chief Long recognized Officer Nic Kennedy. On June 7, 2011 Officer Kennedy arrived on a scene where a man was attempting suicide with a semi-automatic pistol. At great risk to himself, Mr. Kennedy left his position of cover and went face to face with the subject. As a result of Sergeant Kennedy's action, the situation was peacefully resolved, and the subject was taken into custody for treatment. He was awarded the Merit Citation.

Next, Chief Long recognized Brandon Rushing for going above and beyond the call of duty for 104 DUI arrests in 2010. This was also recognized by the

State of Mississippi for a membership in the Public Safety 100 Plus Club. Officer Rushing was awarded the Merit Citation Award.

Next, Chief recognized Officer Brian Rosenberg as he was called to a MVA on I-55 and when he arrived on the scene, he found the victim unconscious and with no pulse. He immediately started CPR until EMS arrived on the scene. Thanks to his efforts, the victim was transported in serious condition have regained a pulse rate. Officer Rosenberg is awarded a Citation for Lifesaving.

RESOLUTION FOR THE AMENDMENT TO TITLE VIII LICENSES AND MISCELLANEOUS BUSINESS REGULATIONS.

WHEREAS, the governing authorities of the City of Southaven have determined that there is a growing need to further regulate time periods allowable for transient vendors to conduct business within the city limits for the greater good of the community; and

THEREFORE BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF SOUTHAVEN, MISSISSIPPI, THAT TITLE VIII CHAPTER 7 SECTION 8-164 (c) OF THE CITY OF SOUTHAVEN CODE OF ORDINANCE BE AMENDED AS FOLLOWS:

Sec. 8-164 License issuance, term, renewal transfer.

(c) A license may only be renewed one time per calendar year for a period not to exceed ninety (90) days. After expiration of the license, the transient vendor must vacate the City of Southaven limits until the start of a new calendar year. At the start of the new calendar year, a transient vendor may

reapply for a license and shall be allowed one (1) renewal. No transient vendor license will exceed one hundred and eighty (180) days of any calendar year.

RESOLUTION FOR THE AMENDMENT TO TITLE XIII ZONING ORDINANCE CHAPTER 6 SIGN REGULATIONS.

WHEREAS, the governing authorities of the City of Southaven have determined that there is a need to further define the time periods for the erection of political signs allowed within the city limits for the greater good of the community; and

THEREFORE BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF SOUTHAVEN, MISSISSIPPI, THAT TITLE XIII CHAPTER 6 SECTION 13-6 (5) OF THE CITY OF SOUTHAVEN CODE OF ORDINANCE BE AMENDED AS FOLLOWS:

Sec. 13-6 General.

(5) Political signs are to be limited to one (1) sign per premises, not to exceed the allowable square footage for the zoning district in which the sign is placed. No sigh shall be permitted on private property without permission of the owner. Signs may not be posted until forty-five (45) days before the election cycle and must be removed five (5) days after the election cycle, any election to which it refers.
